***Education Policies and Procedures***

**"FOR YOUR INFORMATION"**

1. Please arrive no later than class start time. Later arrivals create a distraction. We ask that all students park in the rear lot or on Tesiny Avenue. Please **DO NOT** park in front lot or neighboring business's lots.
2. Students are to use the **North Entrance only - (see sign for Real Estate School of New England)**. Students may not use the **South Entrance to enter or exit – this is an emergency exit only**.
3. Under state rules, students are required to attend 60 hours of classroom time. Students may return in subsequent cycles for makeup or review without additional tuition.
4. Reading assignments are listed on each class syllabus, under each class topic. Please be sure to read chapters in advance of each class. Text = yellow book, Supplement = blue & white book
5. Please be sure to shut off all cell phones and pagers as they create a distraction.
6. A Mid-Term Quiz will be given and consists of 50 questions.
7. The School Exam will be given during the final session. The test consists of 100 questions, a minimum score of 70% is required. Results will be available by the end of the following day, you will be contacted by phone with your test results. After passing the school test, you will receive an "AFFIDAVIT" and an application pamphlet needed for the state exam. This procedure will be discussed in the final session. In the event you do not pass the School Exam during the final session, you must schedule your test by appointment only, please call Olga at 279-4287.
8. When you have received authorization from Hartford to take the exam, you may schedule your computer test. There is a testing center on Rte, 7 in Norwalk, opposite the Merritt 7 complex.
9. If you feel uncomfortable with the course material, you should consider purchasing additional study materials available at the Real Estate School of New England: You may purchase these study materials from Olga Kaminskiy. Olga will visit the classroom a few minutes before the class starts and during your break (on most days). You can also make arrangements to pick up these study materials by calling Olga at 279-4287.
