Principles and Practices of Real Estate “For Your Information”

1. Please arrive no later than class start time. Later arrivals create a distraction. Please DO NOT park your car in neighboring business's lots.
2. Under State rules, students are required to attend 60 hours of classroom time. Students may return in subsequent cycles for makeup or review without additional tuition.
3. Reading assignments are listed on each class syllabus, under each class topic. Please be sure to read chapters in advance of each class. Text = yellow book, Supplement = blue & white book.
4. Please be sure to shut off all cell phones and pagers as they create a distraction.
5. A Mid-Term Quiz will be given and consists of 50 questions.
6. The School Exam will be given during the final session. The test consists of 100 questions; a minimum score of 70% is required. Results will be available by the end of the following day; you will be contacted by phone with your test results. After passing the school test, you will receive an "AFFIDAVIT" and an application pamphlet needed for the state exam. This procedure will be discussed in the final session. In the event you do not pass the School Exam during the final session, you must schedule your test by appointment only, please call Karen at 203-374-9451.
7. When you have received authorization from Las Vegas to take the exam, you may schedule your computer test. There is a testing center on Rt. 7 in Norwalk, opposite the Merritt 7 complex.
