1. Please arrive no later than class start time. Late arrivals create a distraction. Please DO NOT park your car in the neighboring business' lots.

5. A Mid-Term Quiz will be given and consist of 50 questions.
6. The School Exam will be given during the final session. The test consists of 100 questions; a minimum score of 70% is required. Results will be available by the end of the following day; you will be contacted by phone with your test results. After passing the school test, you will receive an “AFFIDAVIT” and an application pamphlet needed for the state exam. This procedure will be discussed in the final session. In the event you do not pass the School Exam during the final session, you must schedule your test by appointment only, please call Karen at 374-9451.
7. When you have received authorization from Las Vegas to take the exam, you may schedule your computer test.
